FOUNDING AFFIDAVIT IN SUPPORT OF A HARASSMENT ORDER

I, the undersigned,

PAUL ANTHONY MULLON,

Hereby make oath and state the following:

- 1.1. I am the Applicant in this matter, an edult male with full legal capacity residing at 52 Monte Carlo Drive, Centurion Residential Estate, and employed as a director at The Digital Marketing Company (Pty) Ltd.
- The contents of this affidavit falls within my own personal knowledge and are 1.2. both true and correct unless the contrary appears therefrom.
- The Respondent herein is Anthony Beamish, a journalist in the employ of 2. Combined Artistic Productions CC, a closed corporation registered in terms of the Company Laws of the Republic of South Africa with main place of business at Tulbagh North, 369 Oak Avenue, Randburg. I am not aware of the further particulars of the Respondent.
- This application is launched in terms of the Protection from Harasement Act, 3. Act 17 of 2011 ("the Act".)

This Honourable Court has the required jurisdiction to adjudicate this application as the Respondent is employed within the jurisdictional area of the Court.

BACKGROUND

- The Respondent only became known to me on or about 22 March 2016. 5. Although I have not met the Respondent he clearly had done some investigations about me and also threatened to attend to my residence; issue civil summons against me; have me charged criminally; and also listed me as a "default payer" on the system of TransUnion ITC without any grounds
- I would like to bring to this Honourable Court's attention that the Respondent is an award winning journalist, employed by United Artistic Productions CC, who is responsible for the production and airing of the well-known actuality program Carte Blanche.
- 7 The causal link between the Respondent and myself can be described as the fact that the Respondent had published various articles and aired visual programs regarding Ronald and Darren Bobroff ("the Bobroffs"), relating to their attorney firm Ronald Bobroff and Partners, who instructed my company to provide website services from 2013 onwards, I was hereafter size mandated to register, create and maintain two websites, instructed by the Bobroffs, known as www.toutingsttorneys.co.za and www.ronaldbobrqff.com. ("the websites").
- 8. I confirm that I was originally the registrant of the two aforesaid websites, but after continued harassment and demands by the Respondent it was decided that I will transfer the relevant domains to Mr. Ronald Bobroff, which was affected during May 2016, after application was made to Afrihost (Pty) Ltd. (the hosting company), on 14 May 2016.
- At this stage I deem it not necessary to delve into the relationship between the 9, Respondent and the Bobroffs, as this relationship falls outside the scope of this application. The conduct of the Respondent regarding the Bobroffs and his continued attempts to implicate me with them however constitutes harassment which not only causes me fear but also financial harm.

HISTORY

- 10. The first interaction that I had with the Respondent was when he contacted me telephonically on 23 March 2016 at 03:30 (half past three in the morning) to discuss publications on the websites. As will become clear hereunder the Respondent recorded all our discussions, which was initially not disclosed to me. If regulted by this Honourable Court these recordings will be made available.
- 11 As would be expected when you receive a call at 03:30 in the moming, I was not very impressed with the Respondent, neither talkative.
- 12. On 23 March 2016 the Respondent again contacted me and effectively examined me on my profession; stated that I was the owner of the websites; and that all statements and publications on the websites were authored by me.
- 13. After I confronted the Respondent about his previous cell at 03:30 in the morning, he sarcastically informed me that the websites are online all of the time, and if I do not want to receive calls after hours that I should then "shut down" the websites after hours.
- 14. On 8 May 2016 the Respondent again contacted me and threatened to visit me at my residence; and that I must remove all defamatory statements published on the website.

RECENT EVENTS

- The Respondent, without any further notice or basis, reported me to TransUnion ITC as a bad debtor on 10 May 2016, when an entry was recorded against my credit profile under "default data", recoding that the default emount of R 860 000.00 (Eight Hundred and Fifty Thousand Rand) was due to the Respondent, and that the debt description was that of a bad debt written off.
- The Respondent reported the listing on 9 May 2016, and supplied me with proof thereof on 10 May 2016. A copy of his e-mail to me and listing is attached hereto marked Annexure "PM 1". This e-mail was sent at 14:46 on 10 May 2016.

- 17. At 15:24 on 10 May 2015, the Respondent sent a further e-mail to me, and attached a link to an audio-visual insert to be aired on Carte Blanche regarding the Bobroffs. A copy of this e-mail is attached hereto marked Annexure "PM 2". This e-mail specifically records that the Respondent warned me to first have a look at the insert and then respond to him. He also warned me of a substantial claim against me.
- To make things worse the Respondent then contacted my relationship manager 18. at Absa Bank and informed her of the adverse credit listing against my name. He then followed the discussion up with an e-mail confirming the listing. transmitted at 16:46 on 10 May 2016. I attach hereto a copy of the e-mail by the Respondent directed to Ms. Caroline Deyzel of Absa Bank, marked Annexure "PM 3".
- 19 I deny that I was aver indebted to the Respondent for any amount.
- On 13 May 2016 I consulted with my current attorney of record, Gerhard Botha 20. of Gerhard Boths Attorneys (herein after referred to as "Boths"), regarding the adverse listing on TransUnion ITC, and my remedies available to the allegations made by the Respondent.
- 21. Ouring our first consultation Botha contacted the Respondent to discuss the ITC listing, and the Respondent informed him that he should contact the Respondent's attorney, Mr. Anthony Miller.
- 22. Botha then proceeded and directed two letters to Mr. Miller on 16 March 2016. copies thereof attached hereto marked Annexure "PM4" and "PM5" respectively.
- 23. in terms of the first letter of 16 May 2016, Botha recorded that the Transitinion listing was tantamount to extortion, and requested that the listing must either be removed or supporting documentation confirming the listing be supplied. It was also recorded that the listing was placed in dispute with TransUnion ITC. and that a copy of this letter will be supplied to TransUnion ITC in support of the application of removal.
- In the second letter to Mr. Miler it was further recorded that I merely acted as 24. web-master of the websites, and that I did not publish or created any of the content contained therein. The letter further also confirms that the Respondent

would attempt to use unsolicited telephonic recordings to gether statements from me. My right regarding a Haressment Application was also reserved.

- 25. To date the only response received from Mr. Miller was an e-mail dated 28 may 2016, wherein it is stated that "... having regard to the impending institution of legal proceedings against your client by our client and others, that in the circumstances no further response is required." A copy of this e-mail is attached herelo marked Annexure "PM 5".
- I confirm that the TransUnion ITC listing against my name was removed, 26. without any input or instruction by the Respondent, on 20 May 2016. I attach hereto confirmation of the removal of the default listing, marked Annexure "PM
- After the removal I received no further communication from the Respondent up until 30 May 2015, when he again contacted me directly via e-mail regarding a publication on 30 May 2016, when he demanded that all "untrue information" regarding a publication on www.ronaldbobroff.com. I attach hereto a copy of the e-mail received and the article attached, marked Annexure "PM 8".
- 28. As Botha was not available to respond I directed an e-mail to the Respondent et 07:49 on 30 May 2016 to the Respondent, indicating that I am not the owner of the website, and also requested him to contact my attorneys directly.
- 29. In response to my e-mail the Respondent then replied and stated at 08:10 on 30 May 2016 that he will be taking further steps against me, which include criminal charges.
- 30. I then responded to the respondent's e-mail and confirmed that I am not responsible for the content on the websites; and also supplied the respondent with proof of the domain registration of the website of Ronald Bobroff, indicating that I am not the registrant. Copies of the e-mails exchanged are attached hereto marked Annexure "PM 9".
- 31. The Respondent here after turned to his Twitter account, and published at least 3 "twests" wherein he stated the following:

"I have evidence that @paulmulionis a reckless liar and fabricator of malicious tales. He has knowingly stolen money and also conspired with fugitives Ronald @ darrenrb12 NBobroff to gratuitously defame those who exposed their

ll jud

ctiminality. I am to publicly exposed @paulmullon for his own criminal wrong doing."

Copies of these tweets are attached hereto marked Annexure "PM 10".

- 32. The contents of these tweets are deferratory of nature as I am called a liar; that I stole money and conspired to fugitives.
- 33. The Respondent has at least 2242 followers on Twitter, and his tweets were either retweated and or replied by various of his followers, as is clear from Annexure "PM 11" a tweet by consumertumer. A copy of the Respondent's twitter account confirming his follower numbers are attached hereto marked Annexure "PM 12".
- 34. From both the illegal and irregular listing of the Respondent it had been made clear that the Respondent will use anything in his powers to defente and or harass me. The consequences of his actions are that I am facing a real financial risk and will suffer as a consequence of his allegations. The fact that he proactively contacted my relationship manager at Absa Bank is indicative of this fact. It is also noteworthy that he did not oppose the delisting of my details form the TransUnion ITC database. Further legal argument shall be advanced at the hearing of this application in this regard.
- 35. The fact that the Respondent, after 16 May 2016 again decided to contact me directly is also indicative of the fact that he fail and or refuses to accept that his modus operandi to attack me in his crusade against the Bobroffs are illegal and futile. By constantly threatening criminal actions against me the Respondent himself rake the possibility that a charge of extortion can be laid against him.
- 36. When the Respondent realised that I am not the owner of the websites, neither the author of the contents thereof as referred to above, he elected to turn to twitter as a forum of publication where he determed and threatened me, which publication had been received by at least 2242 twitter users.
- 37. Notwithstanding his various threats no action or application had been brought against me.

Sworn statement of Mr Jacobus Hercules van der Merwe dated 2020-01-26

SWORN STATEMENT

I, the undersigned Jacobus Hercules van der Merwe, with ID No. 660313 5025 083 residing at 50 Gouws Avenue, CENTURION and with telephone number +27 82 444 4911, state under oath in English as follows:

- 1. I am the father of Michelle van der Merwe, and her two brothers, one of whom is Jacobus (junior) van der Merwe. I used to be married to the mother of my children, Mrs Cornelia van der Merwe. I have been advised of the alleged sexual assault by a certain Mr Tony Beamish against my daughter at her home on or about 31st May 2019 and the subsequent events thereafter which have culminated in Michelle applying for a protection order against Beamish. I have tried very hard to stay out of the volatile situation that prevails between my daughter, her mother, her brother and her alleged abuser. However, when I heard that her alleged sexual abuser has apparently given her two months to move out of her home, I decided that enough is enough.
- 2. I therefore want to explain the situation with regards to the house, located at Domicile, Eldoglen, in Centurion, where Michelle lives, which is a house I bought in 2007 for the sum of R1,138,325.60. In terms of the divorce order between myself and my ex-wife, she (my ex-wife) was supposed to pay 50% of the cost of the house, which she has not done. She has paid only an amount of R45,473.31, whereas I have paid the balance and therefore have a claim, not only for my share of the house, but also against my ex-wife's share as well, as she owes me that money. I had to continue paying, in order to ensure my children had a roof over their heads.
- 3. Furthermore, a couple of years ago, I wanted to sell the house to recover what is owing to me. However, I could not sell the house, as my ex-wife obtained legal opinion that according to the divorce agreement, as long as any of our children were living there, regardless of if they were now adults or not, I could not either evict her or sell the house. It was after this that my ex-wife induced Michelle to go and stay there, so that I could not execute against her for the money she owes me.

- 4. I find it therefore saddening that Mrs van der Merwe would attempt to evict our only daughter, in favour of a man that has allegedly sexually assaulted her. I can only believe that she has been put up to this by the person that stands accused.


