I the undersigned Rasta Rathakga do hereby make oath and state as follows:

- 1. I am employed as an office parking supervisor by Ronald Bobroff & Partners Inc. Attorneys carrying on practice at 37 Ashford Road, Rosebank.
- 2. I was on duty in the parking area of the practice on 2014-10-13 at about 12h30 or so, when I saw a woman who I am aware is employed by the practice and known to me as Cora, walking out of the building across the office parking area towards a white Land Rover which was parked on the premises.
- 3. She was accompanied by a white man and another woman, who was Indian.
- 4. I observed her to be talking and smiling and freely accompanying the man and woman to his white motor vehicle which then drove out of the office parking area. At no stage did I observe either the man or the woman accompanying Cora to be holding her arms, threatening her or in any way forcing her into the white Land Rover motor vehicle.
- 5. Sometime later, I suppose about half an hour or so, I observed a white VW Polo, driven by the Indian woman enter the office parking area and Cora exit from such vehicle and then walked into the office building.
- 6. I have been advised that Cora has alleged that she was 'kidnapped' by the white man and Indian woman. This is completely absurd and just not true. She clearly was with them of her own accord.
