RE: RONALD BOBROFF & PARTNERS INC / MR RONALD BOBROFF / MR DARREN BOBROFF / MR STEPHEN BEZUIDENHOUT THE LAW SOCIETY OF THE NORTHERN PROVINCES / JENNIFER GRAHAM / MATTHEW GRAHAM

- 1. We represent Ronald Bobroff & Partners Inc, as well as the directors, Ronald Bobroff, Darren Bobroff and Stephen Bezuidenhout.
- 2. We are instructed by our clients as follows:
 - 2.1 Consequent upon a special meeting of Law Society members held last year, Mr Anthony Millar (Millar) came to be elected as president of the Law Society.
 - 2.2 You should be aware that the abovementioned special meeting of the Law Society was requisitioned exclusively by Messrs Norman Berger and their professional staff, the inhouse legal advisors of Discovery Health, Mr Jeffrey Katz and Elton Krawitz, and various directors of Edward Nathan Sonnenberg Attorneys (ENS), who represent Discovery Health. Insofar as you are unaware thereof, we attach hereto the requisition notice for the special meeting marked "Annexure 1", and which was sent by Millar to the Law Society dated 28 January 2015.
 - 2.3 It is common cause that Discovery Health has been embroiled in a highly publicized battle with our clients, with battle is being conducted in the courts, media and at the Law Society.
 - 2.4 In this battle, which is now into its fifth year, the Grahams are being utilized as the proxy for Discovery Health and the Law Society has already recognized in at least three affidavits that Discovery Health is the true protagonist in the matter.
 - 2.5 In the Graham matter, ENS are the attorneys representing Grahams/Discovery, represented by Mr George van Niekerk who has

- addressed voluminous correspondence to the Law Society relating to this matter.
- 2.6 Millar, now president of the Law Society, is on the Discovery Panel of attorneys and has worked or assisted with van Niekerk in the Graham applications and deposed to affidavits therein.
- 2.7 Millar is, in addition, actively involved as attorney of record in a number of legal matters against our clients in which some of our former clients have challenged the common law contingency fee agreements and claimed certain refunds from our clients.
- 2.8 Some of these cases are in fact referred to in the Graham matter and it is clear that Millar and ENS are co-operating to some extent in the legal battles against our clients.
- 2.9 In addition, Millar has been actively engaged in social media discussions with Katz of Discovery and a so-called reporter, Tony Beamish, in discussions about our clients and has made unfavourable remarks in Twitter and Facebook about our clients. An example of some of the comments is attached hereto marked "Annexure 2".
- 2.10 Millar has been at most of the hearings in the Graham matter, prior to his election to the Law Society of the Northern Provinces, as an observer often accompanied by Katz and Beamish, all of whom protest to have no direct involvement in the matter.
- 2.11 Likewise, Katz and his staff have similarly been present during many of the hearings in which Millar's firm is litigating against our clients.
- 2.12. There is clearly a close working relationship between Millar, Katz, Beamish and ENS with the same objective in mind and acting with one common purpose, namely to litigate against our clients and ultimately destroy their reputations and business. This is demonstrated by the following which our clients instructed us to place on record:
 - 2.12.1 Katz, during the hearing of an application for leave to appeal by our clients against an aspect of Mothle J's

judgment, approached our client's Director, Mr Stephen Bezuidenhout, and stated: "Don't waste your time with appeals. We are going to destroy you all". Mr.Bezuidenhout's affidavit to this effect is attached to our client's answering affidavit to the "Graham" Application.

- 2.12.2 Katz stated directly to Mr Darren Bobroff at Melrose Arch Johannesburg on the 16th June 2015, stated "We (Discovery) will see to it that Millar will be your next president". Katz's threat in this regard was specifically referred to in a complaint lodged against Katz with the Law Society in July 2015 and which is in the possession of legal official, Jaco Fourie.
- 2.12.3 Katz tweeted on November 14, 2015 that he was "elated at your (Millars) election". The reason for his elation is obvious.
- We respectfully submit that the series of events we have referred to above can only lead to the conclusion that Millar's election as president of the Law Society is directly intended to bring about the fulfillment of Katz's threats set out above.
- Having regard to all the above, and the ensuing serious conflict of interest involving Millar, we seek your urgent assurance and undertaking, that:
 - 4.1 Millar has not, and will not, be permitted to remain in the Council chamber during the discussion of the "Graham" application, and/or any matter regarding any director or staff member of RBP Inc.
 - 4.2 Millar has not since his election, and going forward, will not have access to any Council agenda or minutes relating to the above matters or persons concerned, and that a separate agenda and minute will be prepared for other Councilors to which Millar will not have access.

4.3 Any matters discussed as referred to in 4.1 above and the minutes and agendas referred in 4.2 above, will not be disclosed to Millar.

To do otherwise would be improper, irregular, contrary to the principles of natural justice, and would irreparably prejudice our client's interests.

We look forward to your urgent response and trust that the Law Society will deal with the matter in the appropriate manner.

All our client's rights are strictly reserved.

REQUISITION IN WRITING IN TERMS OF RULE 16 OF THE RULES OF THE LAW SOCIETY FOR THE COUNCIL TO CONVENE A SPECIAL MEETING

- In terms of rule 16, we the undersigned members, request that the Law Society convene a special meeting to deal with the following proposed resolutions;
 - (a) That the present indefinite suspension of rules 30(2) and 31 to 43 be rescinded and that the Law Society strictly adhere to the rules relating to the elections of councillors.
 - (b) That the present rule 30(2) be amended to substitute the expression

"in the year first following upon the year in which the rules are promulgated and in every third year after the year in which such election is held"

with the expression:


"by no later than 1 April 2015, in the third year following such general election and thereafter in every third year".

MOTIVATION

The statutory constituent of the Law Society of the Northern Provinces, unlike the BLA and NADEL constituents, has had approximately one election in the last 20 years. This is not democratic and it does not allow new ideas and a more energetic approach by the Council to its affairs. It can hardly be said, in the absence of regular elections, that the views of the Council represent those of the members.

That the Society:

- (I) Removes the indefinite suspension of the existing rule 47.3; and
- (ii) Adopts the following new rule 47.4:



MOTIVATION

The current rule provides that the Council may select replacements. This position ignores the will of the members of the Society and is irreconcilable with a democratic society, unless there are no other obvious candidates. It is submitted that this rule, which is similar to the provisions of the Gauteng Law Council, would be the appropriate way to deal with such matters.

- That the following rules of the Law Spolety be amended as stated below:
 - (i) Rule 30A.1.1 by replacing the word "three" with the word "five".
 - (ii) Rule 30A.1.2 by replacing the word "two" with the word "three".
 - (III) Rule 30A.1.4 by replacing the word "Iwo" with the word "one".

MOTIVATION

By far the biggest number of non-BLA and non-NADEL members forming the statutory component of the Law Society of the Northern Provinces practice in Johannesburg and Pretoria. In terms of the current dispensation councillors

practicing in these areas effectively represent approximately 1 000 after leys each, whereas statutory component attorneys practicing in the three smaller provinces represent approximately 50 attorneys each. This skewing of Law Society representation is not democratic and accordingly we propose that the figures must be adapted to more accurately reflect the demographics of the profession and to allow those areas, with a far greater concentration of attorneys, more representation and input in the affairs of the Law Society of the Northern Provinces.

4. To amend rule 25.4 to replace the word "five" with the word "fifty".

MOTIVATION

The quorum rule of the Law Society of the Northern Provinces does not accord with the rules/proposals in other Provinces. The current rule minimises the involvement of members of the profession and the affairs of the profession at meetings that, for a variety of reasons, they cannot attend in person. Increasing the number of proxies will allow representation in respect of a greater percentage of the membership to be heard on important issues.

- 5. The following rules of the Law Society are recorded for convenience sake:
 - *17.4 in the case of a meeting requisitioned under rule 16 the meeting shall be converied for a date not more than 30 clear days after the lodgement of the signed requisition with the secretary and shall be held at such time and at such place in Pretoria or Johannesburg as the President may determine.
 - No business other than that for which a special meeting has been convened may be dealt with at that meeting.
